Mary's team includes Connie Moler, Betsy Nymeyer, Jessica Skay and Elaine Hoffman, who has been the alteration specialist for almost 4 years.

Mary works hard at 2 - 3 markets each year to bring in the freshest, most classy looks to adorn her brides. Currently top bridal lines are LaSposa, Maggie Sottero, Impressions, Eden Bridals and Alyce. Bridesmaids have hundreds of styles to choose from including looks by Alfred Angelo, Bill Levkoff, After Six, Alfred Sung and Impressions. Not to mention the flower girls and the princess look they are all after.

Prom is another great event in the store. In the fall of 2006 Mary did research on expanding her prom department. Micropolitan analysis reports Marshalltown's economic strength

Policom Corporation, an independent economic research firm which specializes in analyzing local and state economies, recently released a report which compares the economic strength of both metropolitan and micropolitan areas across the United States. This report is very positive for the Marshalltown micropolitan area when compared to the other 14 micropolitan areas in Iowa.

The report ranks the economic strength of the Marshalltown area as 166th of the 576 micropolitan areas in the United States. This puts Marshalltown at the 21st percentile for economic strength for micropolitan areas nationwide. The state of Iowa has 15 designated micropolitan areas and Marshalltown ranks as one of the top micropolitan areas in Iowa.

Micropolitan statistical areas must have an urbanized core area of at least 10,000 population but less than 50,000 population and they must be at least one county. These areas were once looked upon as quasi rural areas. The micropolitan area designation was created by the US Census Bureau in 2003 and like the better-known metropolitan area, a micropolitan area is a geographic entity used for statistical purposes based on counties and county-equivalents.

The economic strength ratings are based on how the micropolitan economy has performed. Factors analyzed include earnings, jobs, wages, personal income and income maintenance (welfare) dependency levels, as well as construction and retail information. The formulas used to determine economic strength measure how the economy has behaved, not what has caused it to perform.

Marshalltown has made consistent progress in the past six years on the economic strength analysis report and has moved up from ranking 350th in 2004 to 194th in 2006 to the present 166th. This is objective proof of progress being made and of positive comparisons with state and national communities.
