116th Annual Banquet set for May 28

The Chamber is busy making plans for the 116th Annual Banquet, scheduled for Wednesday, May 28 at Iowa Valley Continuing Education's Dejardin Hall. The event will feature keynote presentation by Mr. Carlos Portes.

Mr. Portes was born in Cuba and came to the United States alone at the age of nine in 1961. He spoke no English, and of course had no money. His parents were trapped in Cuba. Through the assistance of the Catholic Church "Operation Peter Pan" (Pedro Pan) he was relocated to Marshalltown, where he was raised by a kind family, and by shoveling snow and gardening, saved enough money to bring his parents to the U.S. after 6 anxious years of separation. The family decided to settle in New York where Mr. Portes worked 20 hours a day, 7 days a week to support his family, and make ends meet. Achieving marginal financial stability, Mr. Portes returned to high school to complete his diploma.

At the age of 20, he began to work for Allstate Insurance Company, after overcoming adversity in a crippling injury. He began his climb to success as an insurance broker, and soon entered into economics and politics. He was appointed Special Ambassador for Latin American affairs by former President Carter. In 1979, Mr. Portes established his own company, an insurance brokerage firm, in commercial insurance and construction bonding. With the same diligence and drive for success that he had applied in his previous endeavors.

Following the 9/11 attacks, as Chairman of the Red Cross, Greater NY, MAO, he worked at Ground Zero with a small team of volunteers and employees to develop and implement a regional communications plan. He became an "on the spot" translator for international media and the voice of the Red Cross for the Spanish press and Hispanic residents of New York. As the weeks progressed, Carlos continued to provide updated information while working tirelessly to galvanize philanthropic efforts from these audiences, both locally and internationally, and reunite children in foreign countries with their surviving parent. He also worked with the downtown Chinese community, one of those most affected by the disaster in lower Manhattan, assisting with food distribution and organizing support for apartment clean-ups.

A recipient of the prestigious Ellis Island Medal of Honor, Portes was also recently inducted into the Iowa Volunteers Hall of Fame.

The event will also recognize the achievements of the past year, look towards Chamber priorities for the upcoming year, recognize outstanding volunteers leaders, and showcase the talents of the 2014 Chamber Person of the Year and 2014 Community Impact Award recipient.

The Sheep's Stockings



On the west end of Marshalltown's Main Street is a hidden gem; a great locally-owned business that you may have heard of, but never visited. The Sheep's Stockings opened at 126 West Main on May 24, 2012.

"Having lived in Marshalltown for just over eight years, I understand the desire of other needle artists to have a local yarn shop," said owner Gail Thiessen. "The nearest shop requires traveling to another community, which for some supplies can take several hours. People of all ages, more than 50 million in the United States, know how to knit and crochet."

Thiessen shared that knitters and crocheters spend an average of \$893 billion a year on yarn and yarn supplies from brick and mortar stores. The majority of customers come from within a 60 - 90 mile radius, some drive further to purchase from a local yarn shop. These crafts remain steady, even in hard economic times.

"Knitting and crocheting is more than just a craft. Needle Arts foster relationships, build community, and provide a useful end result (clothing articles). Plus, it's enjoyable!" added Thiessen.

The store employs one full-time and one part-time employee, who provide a variety of high quality wool, cotton, silk and alpaca blends of yarn for the hand knitter, crocheter, and crafter for retail sale. We offer

classes in knitting, crochet and fiber spinning for beginners to experienced fiber artists. They also offer knitting and crochet accessories.

"Throughout the year we offer workshops and seminars that feature well-known needle artists and designers," said Thiessen. "In addition, we hold promotional events that draw customers from throughout the state such as an annual Yarn Hop which brings in over 1200-fiber artists over a four-day period to our downtown location. We currently host two evening events where knitters/crocheters can come work on projects while offering an opportunity to socialize with others in their community. We provide a warm and inviting atmosphere where local and regional needle artists can shop for all their fiber needs."

But the services don't stop there. Over the next 12 months, Thiessen has the opportunity to offer the store's customers the ability to learn and interact directly with an industry professional. Hannah Thiessen, who is well known and respected in the international needle arts community will bring her fashion design, art and knitting skills to the business. Hannah is currently the Creative Director for YarnBox, a subscription yarn company; Copy Writer and Social Media consultant for Shibui Knits/Knit-Purl and Zen Yarn Garden. She has and worked as Creative Director/Stylist for Malabrigo Yarns out

"I plan to start a Needle Arts Mentoring Program," added Gail.
"The mission of the Needle Arts Mentoring Program, a project of the Helping Hands Foundation, Inc., is to create community partnerships that promote and encourage relationships between adults and youth, fostering curiosity, creativity and a feeling of achievement through the teaching of needle arts."

Thiessen is a member of the Marshalltown Central Business District and Chamber of Commerce. She is also a strong supporter of the House of Compassion and Halos of Hope cancer foundation.

"Since we opened our doors May of 2012 we have taught 2,120 people to knit, crochet and improve their skills through our ongoing classes, workshops and seminars," added Gail. "On May 24 we will celebrate our second anniversary and invite everyone to stop in and help us celebrate."

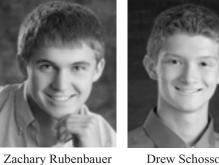
45th Annual Scholastic Banquet

Marshalltown Public Library to host Dust Bowl exhibit

Twenty-five libraries across the country will host the traveling exhibition "Dust, Drought, and Dreams Gone Dry," the American Library Association (ALA) Public Programs Office and National Endowment for the Humanities (NEH) announced.

The public and academic libraries will present the exhibition and related public programs for six weeks each from July 2014 to February 2016. To view the list of selected sites, visit www.ala.org/programming/dustbowl-sites.

"Dust, Drought, and Dreams Gone Dry" features a 300-square-foot exhibit and a series of programs, including lectures and film screenings, designed to foster discussion about one of America's most devastating environmental disasters.

The exhibit and programs feature several overlapping humanities themes: the connection between humans and nature; the ways in which humans respond to adversity; and how people came to understand and describe the experience of living through the drought and dust storms that wreaked havoc on the Great Plains in the 1930s.

The ALA Public Programs Office, the Oklahoma State University (OSU) Library and the Mount Holyoke College (MHC) Library developed the project, drawing upon OSU's "Women in the Dust Bowl" oral histories and MHC's Caroline Henderson papers — letters, essays and articles by a woman who farmed throughout the period. Ken Burns' film "The Dust Bowl" was also an inspiration for the project.

"Dust, Drought, and Dreams Gone Dry" has been made possible in part by a major grant from the National Endowment for the Humanities: Exploring the Human Endeavor.

The ALA Public Programs Office promotes cultural and community programming as an essential part of library service in all types and sizes of libraries. Successful library programming initiatives have included the "Let's Talk about It" reading and discussion series, traveling exhibitions, film discussion programs, the Great Stories CLUB, LIVE! @ your library and more. The website www.ProgrammingLibrarian.org brings librarians valuable information to support them in the creation of high-quality cultural programs for their communities. Communities that have the ability to document and illustrate that area residents are willing to accept new or different employment opportunities, as well as identifying their current and desired wage levels, work experience and level of education have a distinct competitive advantage over those that rely on anecdotal information, unemployment rates or outdated data/information.

There can be multiple audiences for Laborshed information including community development groups, employers, site selectors, utility companies, educational institutions, state and local government agencies, policy makers, grant writers, media and employees. While the Laborshed study cannot answer every question, it can be customized to enhance labor availability information. It can provide insight into workforce characteristics whether the approach is an aggressive marketing campaign, an existing industry program or an analysis of commuting patterns.

In the coming months MEDIC will be hosting a luncheon for the business community to hear from Iowa Workforce Development staff as they present a high level analysis of the data contained in the report and the impacts on the local business community.

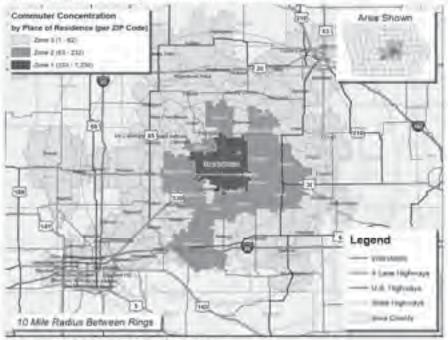




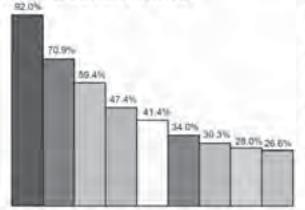
